#### **Discussion**

#### United Way of Lea County - Overview of Project A.L.I.C.E. in New Mexico

Ms. Becca Titus, Executive Director of United Way of Lea County, provided an overview of the A.L.I.C.E. program, an initiative of United for A.L.I.C.E., a national research organization focused on improving the lives of working individuals and families who earn above the federal poverty level but still struggle to afford basic necessities. Ms. Titus stated A.L.I.C.E. stands for Asset Limited, Income Constrained, Employed. These individuals are often employed in essential roles, yet live paycheck to paycheck with little or no savings for emergencies or future needs. Ms. Titus explained that New Mexico is the most recent of 34 states to adopt the A.L.I.C.E. framework. The program aims to highlight and support the growing population of working households facing financial hardship, while fostering nonpartisan dialogue to address systemic challenges and create long-term solutions.

Ms. Titus further explained that A.L.I.C.E. helps shift perceptions by providing clear, data-driven insights into the realities faced by these households. Locally, United Way of Lea County has partnered with organizations such as the JF Maddox Foundation and the Permian Strategic Partnership to launch a three-year data collection effort. This initiative will produce a comprehensive report detailing financial hardship in New Mexico, with data available by county, ZIP code, family type, and other demographics. Ms. Titus announced a community kickoff event is planned for October. Once the date is confirmed, she will send an invitation to the Commission, offering an opportunity to explore the data and better understand the financial landscape of our local communities and the state as a whole.

Ms. Kristi Hughes, Vice Chair of United Way, emphasized that many individuals we interact with daily fall into the A.L.I.C.E. category. They are hardworking employees who contribute meaningfully to our community but still struggle to make ends meet. She expressed her enthusiasm about the opportunity to share this initiative and bring meaningful support to those who need just a little extra help to get by.

Commissioner Mills arrived at the meeting at 6:10 p.m.

#### Action Items

Resolution No. 7647 - Authorizing the City Manager to Enter into a Contract with the Non-Metro Area Agency on Aging for Funding of Meals at the Hobbs Senior Center

Mr. Doug McDaniel, Recreation Director, along with Ms. Mary Puccio, Senior Center Director, presented a resolution authorizing the City of Hobbs Senior Center to enter into a contract with the Non-Metro Area Agency on Aging for funding to support meal

services at the center. The City of Hobbs Senior Center has been awarded up to \$239,615.82 through this contract. The resolution grants the City Manager the authority to execute the agreement, enabling the Senior Center to continue providing vital services, including meal distribution and transportation for seniors. For FY 2026, the Senior Center anticipates distributing approximately 50,400 meals and providing around 3,600 units of transportation. In addition to the potential grant funding, the City of Hobbs is expecting to contribute a local match of approximately \$340,524.06 for meals and transportation services during FY 2025, as outlined in the attached Commitment of Local Funds document.

Mr. McDaniel commended Ms. Puccio and her team for their outstanding work in supporting the senior citizens of the community and for being responsible stewards of the funds entrusted to them.

Ms. Puccio stated it is planned to serve 50,400 meals this year with congregate and home delivery, which is up 2,400 from last year, so the program continues to grow yearly.

Commissioner Fields commented on the band that performed last Friday night, noting how enjoyable it was to see senior citizens out having a good time, dancing, smiling, and truly enjoying themselves.

Ms. Puccio stated dances are held at the Senior Center on the first and third Friday of each month.

There being no further discussion, Commissioner Fields moved to approve Resolution No. 7647 as presented. Commissioner Mills seconded the motion and roll call vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried. # Resolution No. 7648 - Approving the FY 2025 DFA 4th Quarter (June 2025) Financial Report

Ms. Deborah Corral, Assistant Finance Director, explained FY 25 DFA 4<sup>th</sup> Quarter Financial Report. The ending cash balance reported as of June 30, 2025, will be carried forward as the beginning balance for the FY 2026 Final Budget. She stated the ending cash balance for all funds as of June 30, 2025, is \$195,303,432.68. This figure reflects actual revenue and expenditure activity from July 1, 2024, through June 30, 2025. As of the end of the fiscal year, the City of Hobbs has recorded year-to-date actual revenues of \$149,392,468.97 and expenditures totaling \$145,261,555.52.

In response to Commissioner Penick's inquiry regarding the largest source of Gross Receipts Tax (GRT), Ms. Corral stated the retail sector is the largest contributor, accounting for 28% of the total industry average.

Mayor Cobb noted that mining, which includes oil field services, was once the largest contributor to GRT; however, retail has since surpassed it and is now the leading sector.

There being no further discussion, Commissioner Smith moved to approve Resolution No. 7648 as presented. Commissioner Penick seconded the motion and roll call vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried. A copy of the resolution and supporting documentation are attached.

#### Resolution No. 7649 - Adopting the Fiscal Year 2025-2026 Final Budget

Ms. Deborah Corral, Assistant Finance Director, stated the Preliminary FY 25-26 budget for the City of Hobbs was approved by the City Commission on May 19, 2025. She explained the proposed resolution outlining the FY 25-26 Final Budget which incorporates the preliminary budget into the ending cash balance as of June 30, 2025, and now the beginning balance of the FY 26 Budget.

Ms. Corral explained that the budget also incorporates carryovers (items budgeted in the FY 24-25 fiscal year which were not completed) as well as new requests. She explained adjustments to transfers have been made to meet State of New Mexico fund balance requirements, while maximizing the cash balance in the General Fund.

Ms. Corral explained the detail of the budget document. She stated capital carryovers were reviewed along with requests for new money. In the category for new money, an adjustment was made to the Commissioner's special project accounts of \$300,000.00 across the board and added other items to that category. She stated a meeting was held with the City Manager's Office to discuss some items which had been removed from the final budget. Some of those items were added back into the budget, most notably the \$9,000,000.00 infusion into the paving rehabilitation line item which had been cut to \$1,000,000.00 but were able to bring back up to the \$10,000,000.00 requested.

Ms. Corral stated the beginning balance of \$195 million, adding \$22 million to revenue for a total revenue budget of \$165 million, adding \$99 million to expense so the expense budget will be \$250 million, leaving an ending cash balance of \$109 million, with a general fund reserve of 46%.

In response to Commissioner Penick's inquiry about 46%, Ms. Corral stated the reserve percentage includes flowback.

Mayor Cobb commented the City is currently deferring many capital projects, which can eventually lead to a critical need not being met, such as broken water or sewer lines, or fire trucks and ambulances breaking down. He emphasized the importance of finding creative solutions to address these challenges moving forward. While the community enjoys many valuable amenities, he noted that funding mechanisms like HB6 will not restore the revenue previously lost. He reaffirmed that fiscal conservatism has long been a guiding principle in the City's public policy and commended staff for their efforts in managing the situation responsibly.

There being no further discussion, Commissioner Penick moved to approve Resolution No. 7649 as presented. Commissioner Mills seconded the motion and roll call vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried. A copy of the resolution and supporting documentation are attached.

#### <u>Resolution No. 7650 - Authorizing an Allocation of Lodgers' Tax to Fund Various</u> <u>Events for FY 2026</u>

Mr. Toby Spears, Finance Director, stated on July 9, 2025, there was no quorum for the regularly scheduled Lodger's Tax Board meeting. He reviewed the following requests submitted for the meeting along with City staff's recommendation for approval.

Mr. Robert Guthrie, Director of Option, Inc., asked the Commission to reconsider the funding request for Option. He explained the organization is wanting to try something new, a community-driven fashion show event. He stated the event is designed to engage and benefit the local community. He also emphasized that Option, Inc., contributes to the local economy by putting "heads in beds," occasionally providing hotel accommodations when their facility reaches capacity.

Mayor Cobb suggested that Mr. Guthrie return to address the issue at the next Lodgers' Tax Board meeting on October 8, 2025. Mayor Cobb noted the original request lacked sufficient detail and background information which led to the recommendation by staff. However, now that Mr. Guthrie has provided more context, the Commission has a clearer understanding of the intent behind the proposal.

There being no further discussion, Commissioner Calderón moved to approve Resolution No. 7650 with the amounts as recommended by staff. Commissioner Fields seconded the motion and roll call vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried. A copy of the resolution and supporting documentation are attached.

#### Resolution No. 7651 - Approving a Development Agreement with Habitat for Humanity for the Development of Single-Family Housing

Mr. Todd Randall, Assistant City Manager, reported that Habitat for Humanity of Hobbs has submitted a request for a Development Agreement to support the construction of six single-family homes within the city limits. The proposed development is located in a new subdivision adjacent to Mills Elementary School, just off of Fowler Street. Habitat for Humanity is requesting infrastructure incentives totaling \$65,000.00. Mr. Randall noted this agreement follows the City's standard development guidelines and is consistent with the recently adopted housing incentive policy. He also mentioned there is currently \$550,000.00 in carryover funds in the approved budget available to support such projects.

There being no discussion, Commissioner Smith moved to approve Resolution No. 7651 as presented. Commissioner Calderón seconded the motion and roll call vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried. A copy of the resolution and supporting documentation are attached.

#### COMMENTS BY CITY COMMISSIONERS, CITY MANAGER

Mr. Gomez invited Ms. Jessica Silva, Community Services Superintendent, and Mr. Bryan Wagner, Parks and Open Spaces Director, to explain the process of weeds and overgrowth of vegetation, and also the process of spraying for mosquitoes.

Ms. Silva expressed her appreciation for the much-needed rain that Hobbs has received recently. However, she reminded the community that the increased rainfall has led to significant weed growth across the City. City staff is actively working to address related complaints as quickly as possible. The majority of concerns involve infestations of mosquitoes or rodents, often due to overgrown weeds on neighboring properties. Ms. Silva urged all residents to take immediate action by cleaning up their properties promptly to help mitigate these issues. She also emphasized that properties not brought into compliance may be subject to citations.

Commissioner Penick suggested issuing a public announcement through local radio stations and newspapers would be beneficial in raising awareness for Hobbs residents and encouraging them to take pride in maintaining their properties.

Mr. Gomez stated the City of Hobbs takes pride in turning challenges into opportunities for positive outcomes. He stated the ultimate goal in this situation is achieving voluntary compliance, and he emphasized the importance of community support to make that happen. Mr. Gomez stated this is a community effort. He encouraged citizens to contact the City if they notice an issue on a neighboring property and are unable to address it directly with the neighbor.

Ms. Silva encouraged residents to report any code-related concerns by calling Code Enforcement directly or by using TextMyGov for added convenience. She stated timely reporting helps the City respond quickly and maintain a safe, clean environment for all Hobbs residents.

Mr. Bryan Wagner informed the public that proactive measures are being taken to help reduce the mosquito population during this time of year. Crews are targeting larval sites and re-treating known areas in advance; however, these efforts are limited to public and city-owned properties. In addition, adult mosquito fogging is underway. Priority is being given to high-traffic areas such as parks, sports fields, schools, public spaces and other locations where people commonly gather. Mr. Wagner also noted that residents may request fogging in their area by calling or emailing the department. He will provide contact information for those who wish to submit a request.

In response to Mayor Cobb's question about whether contact information is available on the City's website, Mr. Wagner noted it is not currently posted but can certainly be made available. He added that the City typically issues public service announcements (PSAs) ahead of any scheduled mosquito spraying activities.

Mr. Wagner also noted that some areas in Hobbs have opted out of mosquito spraying due to health concerns, and those requests are respected. To help residents reduce mosquito populations around their homes, Mr. Wagner offered several practical tips:

- Remove standing water in and around the home.
- Empty and scrub items like buckets, tires, toys and birdbaths that can collect water.
- ➤ Ensure that pools, hot tubs, and backyard ponds are well-circulated and properly maintained.
- ➤ Talk to neighbors to raise awareness and encourage them to take similar preventative actions.
- Visit local hardware stores for mosquito deterrents such as torches, candles, granular repellents, and skin-safe sprays.

Residents interested in having their properties sprayed can contact the Parks and Open Spaces Department by calling 575-397-9327 or emailing <a href="mailto:posd@hobbsnm.org">posd@hobbsnm.org</a>. When reaching out, Mr. Wagner stated to please provide an address so staff can add it to the service list.

Mr. Gomez reminded the public about the upcoming Large Item Pickup which is held beginning the first week in August. The dates and locations are as follows:

- South of Broadway: Saturday, August 2, 2025
- > Between Broadway and Sanger: Saturday, September 13, 2025
- North of Sanger and West of Fowler: Saturday, October 4, 2025
- North of Sanger and East of Fowler: Saturday, November 1, 2025

Mayor Cobb reminded the public that if someone does not have the physical capabilities to get items to the curb, they can call and request assistance.

Mr. Gomez agreed with Mayor Cobb and stated anyone needing assistance may contact 575-397-9292 or the City Clerk's Office at 575-397-9200. He also reminded the public about the upcoming Hobbs Animal Adoption Center Vaccine and Microchip Clinic which will take place on Wednesday, July 23, 2025, from 9:00 a.m. to 12:00 p.m. at 702 North Grimes St.

Vaccines will be available for \$20.00 and microchips for \$10.00. The only requirements are that pets must be sterilized and owners must present valid identification. For updates and more information, follow the Hobbs Animal Adoption Center on social media.

Commissioner Mills shared a story about seeing a stray cat, a fox, and a skunk peacefully co-existing in his backyard. He remarked that if a cat, a fox, and a skunk can get along in Hobbs, then there's hope for all of us and we're going to be in good shape.

Commissioner Fields expressed his gratitude to Finance Director Toby Spears and Assistant Finance Director Deborah Coral for their efforts in keeping the public well-informed about the City's financial matters. He also acknowledged Code Enforcement

Superintendent Jessica Silva and the entire Code Enforcement staff for their continued dedication and service to the community.

Commissioner Calderón stated at 83 years old, he has begun his 50th year of teaching.

Commissioner Penick extended his gratitude to Mr. Robert Guthrie of Option and his dedicated staff, commending the phenomenal work they do in supporting and caring for survivors of domestic violence. He acknowledged the significant impact they've had over the years, calling it a tremendous service to the City of Hobbs. He also echoed Mr. Gomez's comments about the importance of positive reinforcement, expressing his full agreement. Commissioner Penick stated the City previously had a program that recognized beautiful yards or businesses of the month and expressed interest in reviving it. He emphasized the value of such initiatives in encouraging residents to take pride in their properties and contribute to the beautification of Hobbs.

#### <u>ADJOURNMENT</u>

There being no further business or comments, Commissioner Calderón moved that the meeting adjourn. Commissioner Mills seconded the motion and the vote was recorded as follows: Smith yes, Mills yes, Fields yes, Calderón yes, Penick yes, Cobb yes. The motion carried and the meeting adjourned at 7:50 p.m.







The Director of the Alcoholic Beverage Control Division (ABC) has reviewed the referenced Application and granted **Conditional Preliminary Approval**. It is being forwarded to you for Local Option District approval or disapproval of the Liquor License Application.

- 2) Request from ABC an extension of time, past the forty-five (45) days, designating how much additional time will be needed to conduct the hearing in compliance with all statutory and



regulatory procedures. After the extension is granted and the hearing is held, notify ABC of your decision within thirty (30) days of the hearing;

ABC has no preference in the option you choose.

The governing body is required to send notice by certified mail to the Applicant of the date, time, and place of the Public Hearing. The governing body may designate a Hearing Officer to conduct the hearing. A record shall be made of the hearing.



#### Summary:

In its continuing promotion of safety and clean-up efforts within city limits, the Hobbs Police Department-Community Services Department has identified properties which present health, life and safety hazards, which warrant remediation. The properties are in dire need of repair. The properties located at 525 N Burk, 408 E. Humble and 103 E. Vega are ruined, damaged and dilapidated and a menace to the public comfort, health and safety. Attachment A contains the information for the properties.

WHEREAS, pursuant to Section 8.24.010 of the Hobbs Municipal Code, and Section 3-18-5 NMSA as amended, the City has inspected the premises described in Attachment "A", attached hereto and incorporated herein by reference, and finds that the structure thereon are ruined, damaged, and dilapidated, are a menace to the public comfort, health and safety and requires removal from the municipality.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF HOBBS, NEW MEXICO, that the structures described in Attachment "A" are found to be ruined, damaged and dilapidated, are a menace to the public comfort, health and safety, and should be removed.

BE IT FURTHER RESOLVED that a copy of this Resolution be served on the owner, occupant or agent in charge of such premises; and that a copy of the same be published as required by law.

BE IT FURTHER RESOLVED that unless the owner, occupant or agent in charge of such premises, within ten (10) days from such service or posting and publication of this Resolution, has commenced removing such structures from the real

property or has filed written objection with the City, the City shall cause the removal of such structures at the cost and expense of the property owner.

BE IT FURTHER RESOLVED that in cases where the City removes a structure so condemned, a lien shall be levied by the City against the real property involved in an amount equal to the reasonable cost of the services rendered, which lien may be foreclosed in default of satisfaction.

#### Summary:

In the FY26 budget, the Street Dept. budgeted for the replacement of two street sweepers that have exceeded their useful life. The department would like to use an HGACBuy contract to purchase two Schwarze Model M6SE Avalanche High Dump Mechanical Street Sweepers. Consideration was given to various types of sweepers, but following research and live demonstrations, a mechanical sweeper was identified as the best option for the debris most often encountered on our City streets, which includes gravel, sand and leaves. The life expectancy of a street sweeper is 8-10 years.
